2. Will be receiving after confirmation of participation will be notified via email upon receipt of duly completed Application Form, Artist shall pay the amount of total by the deadlines provided for data that will be provided via email indicated in the application form

Artist also agrees to keep faith with commitments under the Association QueenArtStudio aware that it may withdraw after confirmation of participation or the closure of admissions ,after terms established by law, worth full payment Artworks will be agreed by the artist with our organization that has the right to approve them by 20 MAY 2020 and must be delivered, to the address given in the case of admission no later than 25 MAY 2020
4. Works will be sent by the Artist in Padua to QueenArtStudio studio (in Padua) or delivered personally in Monaco directly at the Fair during the installation, or even personally in Padua in the Gallery on the dates that will be indicated when confirming participation from where they will then be transported to Monaco by QueenArtStudio
5. NOTE: * Cost of transporting artworks from Padua to Monaco and to return via our courier shall be borne by the artist and will be calculated based on the size of Works, and will be counted together with shares No liability will be charged to Organization for damages to Works due to transport from Padua to Monaco and return,and even during the show (eg for theft, fire, damage by third parties etc.)not even for incoming works in Padua,and from Padua to the artist's domicile in a consignment withdrawn by his own courier.
6. You should send artworks without glass due to damage during transport, provided compulsorily to brackets (only one on the back, and frame, if required, under the measures required) and store in containers wood or polystyrene affixed to any works of ceramics and the like. Insurance requests paid by the Artist will be considered
7. Will not be exposed works not comply with the Regulation or in excess of the size required in some way.
8. In case of booking space for multiple Mini solo exhibition Works, arrangement of Works will have a dedicated area In case of failure to pay the share of fixed dates and behavior deviates from the good performance of the Fair or damage which causing the Organization Image , QueenArtStudio reserves the right to exclude from participation in the artist defaulting and to request damages arising
